RTI Consultation Support



A solution to support the effective use of data and assessments to impact instruction.

Response to Intervention is a powerful approach to best meet the needs of all students. Districts are required by the state to have a Response to Intervention plan for K-4 ELA, but many have adopted the RTI approach as a K-12 philosophy for the support of students, teachers, and instructional programs.

Considerations for successful implementation of Response to Intervention include:

- A clear RTI plan that minimally addresses state requirements
- Processes and structures that support the implementation of an RTI plan
- Consistent assessment practices across and within grade levels
- Effective use of meaningful data to inform decision-making
- Strategies and criteria for three tiers of intervention

RTI requirements at the state level include:

- Appropriate core instruction
- Universal screening of all students
- Targeted interventions
- Repeated Assessments (curriculum measures) to monitor progress
- Application of student data to make educational decisions
- Clear communication with families
- Defined components and structure of RTI at a district-level
- Implementation of RTI program by trained staff

RTI Consultation Support can provide:

- Comprehensive RTI Audit and recommendations for short and long term district goals
- Development of a district RTI plan to meet and exceed state requirements
- Facilitation of process to revisit and revise an existing RTI plan
- Work with district and building level staff to successfully implement aspects of RTI plan
- Guidance in decision-making about universal screening measures and assessment tools
- Facilitation of data meetings that lead to decisions about students and interventions
- Support to build capacity of staff to implement RTI with regularity and independence

Provided service will be customized to best meet the needs of a district. The above list of options are simply a starting point for this work that truly impacts all elements of the educational process. Support may occur on-site and at the CNYRIC, in order to capitalize on the expertise of the Data Warehouse team.
